

TAX CREDITS.

The Work Opportunity Tax Credit

The Employer can claim 40% of the employees' first \$6,000 in qualified wages. And 25% of up to \$6,000 in qualified wages after the employee has worked 120 hours for part-time employees.

Disabled Access Credit

The employer can claim credit for adaptations made to the job and environment for the purpose of disability accessibility.

- B3 Medicaid
- Innovations Waiver Medicaid
